Who can join CCCC?

What is the duration of our membership period?

Membership dues cover the calendar year, January 1 to December 31. Dues received in the last quarter of the year will activate your benefits immediately, and membership will continue through to the end of the next year.

How can the staff of a member organization take advantage of reduced registration?

To take advantage of a member registration discount, your staff must login to our website and make sure their account is linked to the member organization. Once linked, they will automatically see member rates when registering for the Annual Summit and live webinars. All registrations at the member rate will be confirmed for active membership status by our staff. Are continuing education credits available?
